**CADV/VOC** established in 1985, is a non-profit organization that provides crisis intervention, shelter, advocacy, and support to victims of domestic and sexual violence. The highly committed staff and volunteers provide the information, tools, resources and support that empower victims to make and sustain positive choices in their lives. These changes lead to the happiness and security of a life free from violence.

**24-HOUR HOTLINE:** Provided 24-hours a day, 7-days a week, answered by qualified trained staff or volunteers.

**CRISIS INTERVENTION:** Performed by qualified trained advocates to individuals in crisis. To stabilize emotions, clarify issues and provide support and assistance to help explore options for resolution of the individual's needs.

**SAFE SHELTER:** Emergency Housing and related support services provided in a safe, protective environment for women and their children who have been victimized by domestic violence and sexual assault.

**COUNSELING:** Provided to adult female victims of domestic and sexual violence by a Licensed Professional Counselor, offering support of each individual's situation and assists them in dealing with the impact of violence in their lives.

**SEXUAL ASSAULT RESPONSE TEAM:** Trained advocates respond to Lake Regional Health System to provide support and

assistance to victims of sexual and domestic violence 24-hours a day.
